NOTICE AND WARNING OF REGULAR TOWN MEETING
AND ANNUAL BUDGET MEETING

Pursuant to Sections 203, 204, and 205, Woodbury Charter, all electors and citizens who are qualified to vote in Town Meetings of the Town of Woodbury are hereby notified and warned that the Regular Town Meeting and Annual Budget Meeting will be held in the Senior Community Center, 265 Main Street South, Woodbury, on Monday, May 20, 2024 at 7:00 p.m. for the following purposes:

1. To authorize the Board of Selectmen to enter into agreements with the Connecticut Commissioner of Transportation for State Aid for construction, improvements and maintenance of highways or sections of highways and bridges, pursuant to Section 13a-175a through 13a-175j, Connecticut General Statutes;
2. To authorize the Board of Selectmen to dispose of obsolete Town equipment with a potential sale value not in excess of \$10,000 per item by sealed bid;
3. To discuss and act upon the budget presented by the Board of Finance and to adopt a budget for the fiscal year commencing July 1, 2024 and ending June 30, 2025, pursuant to Section 203.A.1 and 702.D of the Woodbury Charter:






